## Important Information about Your Medical Plan Coverage

Dear IUOE 181, 320 & TVA Medicare-Eligible Retiree and/or Dependent,

We are writing to inform you of some changes to the Anthem MAPD Plan, effective January 1, 2026. This change is being made to address the continually increasing costs of coverage and to ensure that Medicare-eligible participants have access to comprehensive coverage at the most affordable cost.

Your Dedicated Advocacy Team at RetireeFirst will continue to assist. They can answer any questions and provide support with the changes being made to your plan.

## Changes and Important things to know:

### **Medical**

- Your maximum out of pocket for medical services will be \$3,400.
- Your one-way trip for ambulance services will be subject to a \$50 copay.
- Your durable medical equipment and supplies will be subject to 10% coinsurance.

### **Prescription**

- Your maximum out of pocket for prescriptions will be \$2,100.

## Mailings to expect:

- You will be receiving a new Anthem MAPD Plan card prior to January 1, 2026. Please keep in mind, Retirees and dependents will receive their own ID card. These may arrive on different days; this is normal.
