Important Information About Your City of Port Neches Retiree Medicare Supplement Insurance Benefits

Dear Medicare-eligible Retiree and/or Dependent,

We are writing to inform you that there will be a change to your Medicare Supplement insurance coverage provided by the City of Port Neches. This change is being made to address the continually increasing cost of coverage and to ensure that Medicare-eligible participants have access to comprehensive coverage at the most affordable cost.

Your new Medicare Supplement Plan will be provided by **United American Insurance Company** effective July 1, 2024.

In addition to the new plan, the City of Port Neches has retained RetireeFirst, a retiree benefits management solutions and advocacy service provider. RetireeFirst Advocates are US-based and available to help you navigate the complex retiree healthcare landscape and troubleshoot any issues you may have with your insurance carrier, provider's office, and pharmacy. RetireeFirst Advocates build real relationships with you and truly care about helping you navigate Medicare, understand your benefits, and connect you to programs that can improve your health and wellbeing. Important Things to Know:

- You must be enrolled in Medicare Parts A and B to participate in the United American Medicare Supplement Plan.
- You will present both your Medicare card and your new United American Medicare Supplement ID card to medical providers.
- No referrals are needed for Medicare covered medical services.

Mailings to Expect in the Coming Months:

- United American Welcome Kit and ID Card
- Please keep in mind each Retiree, spouse, and/or dependent may receive the above items on different days; this is normal.

We are required by law to give you the choice of opting out of the new plan. Since you are currently enrolled in the City of Port Neches Medicare Supplement Plan provided through AARP/UHC, it is unlikely that you would not participate in the new United American Medicare Supplement Plan. However, you have the option to opt-out. If you opt out, you will not have Medicare Supplemental insurance coverage available through the City of Port Neches.
