You will be automatically enrolled into **UnitedHealthcare® Group Medicare Advantage PPO and Prescription Drug (MAPD) Plan with Sav-Rx Wrap**.

About Your New Plan

Important Things to Know:

- Each Retiree will receive a UnitedHealthcare® ID card and a Sav-Rx ID card, containing new ID Numbers.
- You must be enrolled in Medicare Parts A and B to participate in the **UnitedHealthcare**® MAPD Plan.
- Put your Medicare card in a safe place in case you need it later. You will use only your **UnitedHealthcare**[®] ID card for medical services.
- You can use any willing Medicare medical provider, regardless of if the provider is in or out of the **UnitedHealthcare**® network.
- No referrals are needed for Medicare covered medical services.
- The **UnitedHealthcare**® Pharmacy Network contains over 67,000 in-network pharmacies nationwide.

- Be sure to show the Pharmacy your new UnitedHealthcare® Card and your Sav-Rx card for processing. You do not need new prescriptions for retail pharmacies.
- If you are currently using a Mail Order Pharmacy, you will need to have new prescriptions sent to your dedicated Mail Order Pharmacy, Sav-Rx Mail Order.

We are required by law to give you the choice of opting out of the new plan. Since you are currently enrolled in the IBEW Local 697 Health & Benefit Plan Medical and Prescription Drug plan it is unlikely that you would not be able to participate in the new robust UnitedHealthcare® Group Medicare Advantage PPO and Prescription Drug (MAPD) Plan with Sav-Rx Wrap plan. However, you have the option to opt-out. If you opt out, you will not have medical and prescription coverage through IBEW Local 697 Health & Benefit Plan.
